Notice is hereby given pursuant to Florida Statutes Chapter 166.041, the Greenacres Code, Chapter 16-33, and other applicable laws and authority vested in the City Council of Greenacres, Florida, to call and hold public hearings and give notice thereof, that a public hearing will be held to consider the requested annexation.

AN ORDINANCE ADOPTED BY THE CITY COUNCIL OF THE CITY OF GREENACRES, FLORIDA, ANNEXING TWO PARCELS OF LAND TOTALING APPROXIMATELY 4.23 ACRES, LOCATED ON THE SOUTHWEST CORNER OF SUMMIT BOULEVARD AND RANCHETTE ROAD AT 6174 AND 6194 SUMMIT BOULEVARD, AS REQUESTED BY THE PETITIONER, LAND RESEARCH MANAGEMENT, INC., AGENT FOR THE OWNER, TEMPLO DE ADORACION FAMILIAR, INC.; PROVIDING FOR REDEFINING THE BOUNDARY LINES OF THE CITY OF GREENACRES TO INCLUDE THE SUBJECT PROPERTY IN THE CITY'S OFFICIAL BOUNDARY MAP; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

EXPLANATION OF PETITION:

The applicant is requesting voluntary annexation of approximately 4.23 acres into the City.

Located on the southwest corner of Summit Blvd. and Ranchette Road at 6174 and 6194 Summit Blvd.

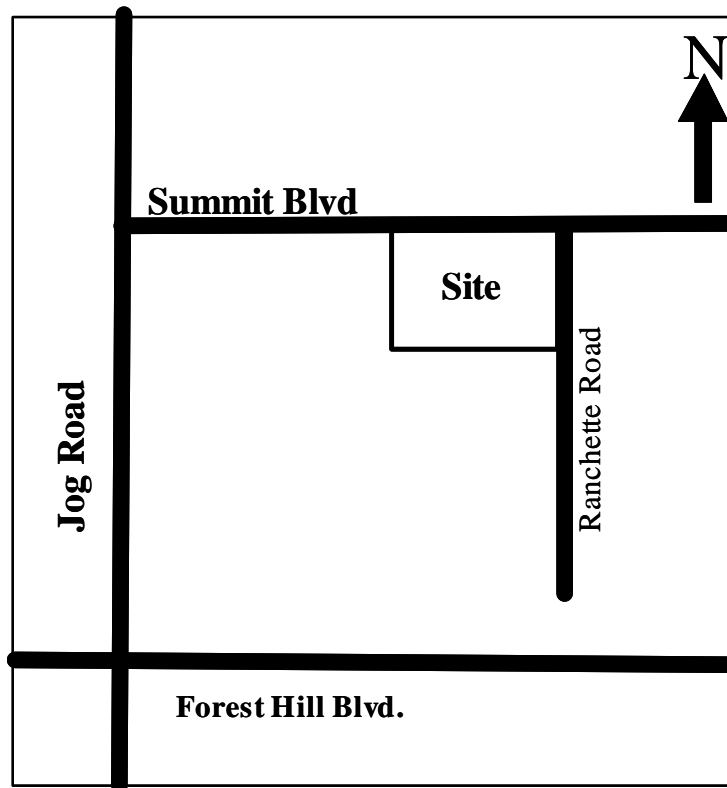
